Landlord Request For Direct Payment Of Local Housing Allowance

Under the Local Housing Allowance (LHA) scheme, we will usually pay benefit direct to your tenant. Your tenant must then pay their rent to you. If your tenant is 8 weeks or more in arrears with their rent, the law allows us to pay LHA directly to you as their landlord / agent, unless it is in the overriding interests of the claimant or his family not to do so, or where we consider that the landlord / agent is not "a fit and proper person" to receive payments direct.

If your tenant does not have 8 weeks or more rent arrears but you think it is unlikely that your tenant will pay their rent or that they are having difficulty managing their affairs then the law gives us the discretion to pay LHA directly to you.

From April 2011 the law has been amended to give us the discretion to pay LHA directly to you where it is to assist your tenant in securing or retaining accommodation.

Please fill in this form and return it to us, together with the proof we ask for. We will send you our decision as soon as we can. Please note that if you cannot send the proof we ask for, it may delay our decision. This may mean that payments will continue to be made to your tenant.
