Guidance Notes for Applicants

One application form is sufficient for all children in the family

SCHOOL CLOTHING GRANT

A grant will be made to pupils of primary and secondary school age attending a West Lothian school, but are not payable for students over the school leaving age. Parents of these students will normally be eligible to receive an Education Maintenance Allowance for the period in which their child stays on at school beyond the school leaving age.

A pupil is entitled once per academic year, and forms for the 2011/2012 academic year will be accepted from **03 May 2011**. The amount you will receive is **£47.00** for a primary school age child, and **£55.00** for a secondary school age child. This will be sent by way of a cheque from our Finance Department direct to your home address.

Parent/guardians must be in receipt of **Income Support, Income-Based Jobseeker's Allowance, or any Income Related element of Employment & Support Allowance.** You will also qualify if you are in receipt of **Working Tax Credit and/or Child Tax Credit** and household income is less than **£15,860**. If the parent/guardian is in receipt of **Pension Credit**, you may also be eligible.

If you do not receive any of these benefits, you may still qualify due to your personal circumstances. In such cases, an accompanying letter is required, and a report is called for from the Children & Young People Team regarding the families' circumstances.

FREE SCHOOL MEALS

Entitlement will be granted to pupils of primary and secondary age attending a West Lothian school. A pupil is entitled for the 2011/2012 academic year providing that the parent/guardian continues to receive a qualifying benefit as described below. If you cease to receive any of the qualifying benefits listed below you should advise this office immediately.

Application forms for the 2011/2012 academic year will be accepted from **03 May 2011**, and if not received by **12 August 2011** the start date will be delayed and entitlement cannot be backdated.

Parent/guardians must be in receipt of **Income Support, Income-Based Jobseeker's Allowance, or any Income Related element of Employment & Support Allowance.** You will also qualify if you are in receipt of **Child Tax Credit only (with no Working Tax Credit)** and your household income is less than **£15,860**. You will also qualify if you are in receipt of **Working Tax Credit and Child Tax Credit** and your household income is less than **£6,420** (maximum Working Tax Credit). If the parent/guardian is in receipt of **Pension Credit**, you may also be eligible.

Primary school aged pupils in receipt of Free School Meals are provided with 0.25 litre of **milk** daily free of charge.

HOW TO PROVIDE PROOF OF A QUALIFYING BENEFIT TO ACCOMPANY YOUR APPLICATION

If you receive **Income Support, Income-Based Jobseeker's Allowance** or **Employment & Support Allowance – Income Related** you should follow one of the steps below:-

1. Take the form to your local JobcentrePlus (DWP), Council Information Services or West Lothian Council Advice Shop (Bathgate) who will put their stamp in the box provided.
2. Take the form, together with all pages of a recent assessment letter (dated within the last 6 months) to your child's school. The details will then be checked and the documents returned to you immediately.
3. Send the form to the address below together with all pages of an award letter (dated within the last 6 months). The details will then be checked and the document returned to you.

If you receive **Working Tax Credit and/or Child Tax Credit**, you should follow one of the steps below. Please do not apply if you have not yet received your new Tax Credit Award Notice detailing payments from 06 April 2011 onwards. Please note that a Tax Credit Annual Review is not acceptable, as this is your invitation to renew and does not state household income.

1. Take the form, together with pages 1 to 4 of your **new** Tax Credit Award Notice to your child's school. The award notice will then be photocopied and returned to you immediately.
2. Send the form to the address below together with pages 1 to 4 of your **new** Tax Credit Award Notice. The details will then be checked and the document returned to you.
