COMMUNITY BENEFITS IN PROCUREMENT: NOTE FOR SUPPLIERS

Background

The purpose of this note is to inform all potential suppliers to West Lothian Council (the council) of our commitment to maximise Community Benefits from our procurement activities.

The Local Government in Scotland Act 2003, the Public Contracts (Scotland) Regulations 2015 and European Procurement Directives enable public bodies to include Community Benefits in the procurement process in certain circumstances.

On 4 June 2013, the council implemented a Community Benefits in Procurement procedure which outlines the approaches the council will follow to include specific clauses within procurement contracts known as Community Benefit Clauses.

West Lothian Council's Commitment

The council will carry out a tendering exercise for all supplies, services and works contracts with an estimated value of £50,000 and over.

The council has made a commitment to consider the inclusion of Community Benefits from the outset of each tendering process.

What are Community Benefit Clauses?

Community Benefit Clauses are contractual requirements with suppliers to deliver wider benefits in addition to the core purpose of the contract. These clauses can be used to build a range of economic, social or environmental conditions into the delivery of council contracts.

The principles of Transparency and Non-Discrimination are critical to ensuring that Community Benefits are legally incorporated within the council's tendering process.

Transparency

The council will issue a Community Benefits statement within the Contract Notice giving suppliers a clear indication that the contract to be awarded may include provisions to achieve Community Benefits.

Non-Discrimination

The council will also ensure that the inclusion of Community Benefits will never directly or indirectly disadvantage or discriminate against tendering suppliers outwith West Lothian.

The council has two approaches to incorporating Community Benefits; one process for Construction Projects and one process for Non-Construction Projects.

Approach for Construction Projects

The council has adopted the National Skills Academy for Construction Client Based Approach. The National Skills Academy guidance provides a toolkit to deliver employment and skills Community Benefits (e.g. apprenticeships, jobs, subcontractor training etc.) across a variety of construction project values and construction project types (e.g. residential houses, highways and roads, schools, house repairs etc.).

Approach for Non-Construction Projects

Evaluate

For non-construction projects the council will aim to evaluate Community Benefits proposals as part of contract award criteria. The council will stipulate to suppliers the Community Benefits required within the tendering documentation. These Community Benefits will be directly related to the 'core purpose' of the contract.

Non-Evaluation

As an alternative to stipulating specific Community Benefits requirements, the council may instead seek Community Benefits proposals from suppliers. In such cases the Community Benefits proposals provided by suppliers will not form part of contract award criteria and will not be evaluated when determining the winning tender.
