#### 1. INTRODUCTION

### 1.1 PURPOSE OF THE REPORT

The purpose of this report is to give information on:

- West Lothian Council's proposal to relocate Holy Family Primary School, Winchburgh as part
  of West Lothian Council commitment to providing quality and long term sustainable
  educational provisions for all pupils.
- the Consultation Process
- Consultee Responses
- Notes of Public Meeting

### 1.2 SUMMARY OF PROPOSAL

West Lothian Council, Education Services proposes to relocate Holy Family Primary School, Winchburgh to a proposed identified site west of Winchburgh town centre.

This will address the demand ongoing housing developments will have on predicted school capacity in Winchburgh and ensure West Lothian Council meet statutory educational responsibilities.

## 1.3 BACKGROUND

Holy Family Primary School is currently in shared premises with Winchburgh Primary School.

The continuing expansion of the Winchburgh Core Development Area means there is requirement to provide a purpose built education establishment and relocate the existing Holy Family Primary School as well as make effective use of existing and future school capacity.

## 1.4 TIMELINE

The following timeline was established and incorporates the organisation of a public meeting, Education Scotland involvement, the preparation and publication of the report on the outcomes of the consultation and subsequent submission to West Lothian Council Education Executive for its decision in January 2020.

#### 1.5 CONSULTEES

In terms of the Schools (Consultation) (Scotland) Act 2010, any proposal to make amendments to the school estate in this case, relocation of a school, requires a formal consultation.

The Schools (Consultation) (Scotland) Act 2010, as amended by the Children and Young People (Scotland) Act 2014, sets out the statutory consultation requirements.

The statutory consultees for a proposal to relocate an education establishment are prescribed as follows:

- the Parent Council or Combined Parent Council of any affected school
- the parents of the pupils at any affected school
- the parents of any children expected by the education authority to attend any affected school within two years of the date of publication of the proposal paper
- the pupils at any affected school (in so far as the education authority considers them to be of a suitable age and maturity)
- the staff (teaching and other) at any affected school
- any trade union which appears to the education authority to be representative of the persons mentioned in bullet point above
- the community council (if any)
- the Community Planning Partnership (within the meaning of section 4(5) of the Community Empowerment (Scotland) Act 2015 for the area of the local authority in which affected school is situated.
- any other community planning partnerships considered relevant by the Authority.
- any other education authority that the education authority considers relevant
- any other users of any affected school that the education authority considers relevant
- in relation to any relevant proposal which affects a denominational school, the Church, Denominational Body or Scottish Hierarchy of the Roman Catholic Church

### **1.6 CONSULTATION PROCESS**

The consultation period incorporated a period of 30 school days (excluding any school holiday) from Thursday 26 September 2019 until Friday 15 November 2019. This timescale adheres to the statutory consultation period for such circumstances which is a minimum of 6 consecutive weeks and include at least 30 school days.

Public meetings were conducted at Holy Family Primary School, Winchburgh, on Thursday 10 October 2019. Council officers outlined the key elements of the proposed relocation of Holy Family Primary School and answered question from meeting attendees. Comprehensive minutes of the public meetings are detailed in Section 3 of this report.

### **Summary of Proposal:**

Relocate Holy Family Primary School to a proposed identified site west of Winchburgh town centre.

Delivery of a viable and sustainable educational establishment equipped with modern provisions To optimise the educational experience for all pupils.

Rationale:

West Lothian commitment to providing quality and long term sustainable educational provisions for all pupils

Review of current and projected pupil roll indicators for Holy Family Primary School and Winchburgh Primary School

Consider implications arising from new housing developments

Ensure new housing developments have specified catchment schools

Holy Family Primary currently in shared premises with Winchburgh Primary School

### **Group Discussion**

James Cameron commenced discussions by advising that by offering due regard to the positive and informative dialogue conducted as part of the previous pre-consultation exercise, Council officers have made no change to the initial proposal of relocation of Holy Family Primary School to an identified site on the B9080 to the west of Winchburgh village centre.

### Response:

Meeting attendees warmly received this information.

When advised by Council officers that the new school will initially be constructed as a single stream school a meeting attendee asked for a further explanation as to what exactly a single stream school will entail.

#### Response:

It was explained that a single stream school has capacity to accommodate 231 pupils. Whilst this is based on the scenario of 33 pupils per class it was further explained that class sizes will vary in accordance to statutory guidelines i.e. a max of 33 pupils per class is permitted for year stages P4-P7 however guidelines dictate smaller pupils numbers for year stages P1-P3 (25 in P1 and 30 in P2-3) and a maximum of 25 pupils per class for any composite class arrangements.

It was further explained that whilst the current pupil roll at Holy Family Primary is not at the 231 maximum, the provision of a new single stream school allows reasonable opportunity for growth.

A question was raised in relation to start and finishing times at the new Holy Family Primary School and the implications this will have on childcare arrangements. It being explained to officers that current childcare assistance involves collection of pupils from both Holy Family and Winchburgh Primary Schools. Concern was raised as to how this will this be possible if located on different sites?

## Response:

Council officers acknowledged this comment.

If there was an identified requirement to alter school start and finishing times this would be something that the Head Teacher would take responsibility for and initiate a local consultation. This consultation would review the impact a change to the school day may have on matters such as nursey provision, school crossing patrols, school transport and teaching hours. Details of any proposed community consultation in relation to change to the school day must be relayed to the Authority in the first instance.

Having reviewed proposed design of the new school, a meeting attendee raised a small concern in relation to the allocated space in the cloakroom areas and asked whether it was felt this proposed allocated space was sufficient?

## Response:

Again, this comment was welcomed.

Council officers offers drawings of the planning design intentions and indicated that the area in question conforms to legislative requirements and that all design intentions conform with standard size requirements.

It was further explained that in depth dialogue had already taken place and is indeed ongoing with Space Zero, the company assigned to ensure all elements of the proposed new school allow a vibrant and sustainable learning hub for all school users.

Meeting attendees, on review of the design schedule, proceeded to ask a number of questions in relation to the specifics of the design i.e. access to upper floor levels, access to outside space Response:

Council officers welcomed each question and with the aid of displayed design specifications responded accordingly.

Road infrastructure and traffic management was highlighted by an attendee for discussion and clarification.

### **Response:**

It was advised that traffic management considerations are ongoing. Meeting attendees were offered a visual whereby proposed access points, crossing points and traffic management provisions were detailed.

It was further explained that Roads and Transportation have already and continue to conduct assessments to determine suitable walking routes.

## **Next Steps**

Collate and review feedback received from Statutory Consultation discussions

November 2019 – West Lothian Council will submit report on findings of Statutory Consultation to Education Scotland for review

December 2019 – On receipt of response from Education Scotland, West Lothian Council will prepare and publish Final Consultation Paper

January 2020 - West Lothian Council Education Executive review Final Consultation Paper and make final decision on proposal.

Cllr David Dodds concluded the meeting by thanking attendees for their attendance and participation in discussions.

### 4. ANALYSIS OF CONSULTATION RESPONSES

The attendees at the Statutory Consultation Meeting warmly received the consultation proposal, and sought clarification of various aspects of them. Concerns regarding detailed aspects including childcare and cloakroom space were responded to and taken on board

No expression of opposition to the proposal was received during the statutory consultation.

### 5. REPORT BY EDUCATION SCOTLAND

Education Scotland has written a report on West Lothian Council's proposal to relocate Holy Family Primary School, Winchburgh.

Education Scotland agrees that the proposal, should it be approved, will bring educational benefit to the children in Holy Family Primary School, Winchburgh. All members of the school communities of Holy Family and Winchburgh Primary Schools expressed their wish for the strong joint work to continue in future. Stakeholders welcome West Lothian Council's Commitment to continue to engage with staff, pupils and parents throughout the development of the proposed new building.
