## **Explanatory Notes – Sole Resident Discount**

The full Council Tax bill assumes that there are two adults resident in a property. If only one adult (person aged 18 years or over) is resident at a property, a 25% discount can be awarded.

**To apply for discount,** the person liable to pay the Council Tax should complete this form and sign the declaration.

**Please note** that if you are asking for discount to be backdated, you may have to provide evidence to support your claim.
