## 1. Introduction

This statement sets out West Lothian Council's determination under Regulation 10(1) of the Environmental Assessment (Scotland) Act 2005 on whether or not a Strategic Environmental Assessment (SEA) is required for Supplementary Guidance (SG) – Developer Contributions Towards Cemetery Provision.

Screening is the first stage in the SEA process. The purpose of screening is to establish whether or not a Plan, Programme or Strategies (PPS) will have significant environmental effects. Screening takes the form of a formal submission, where the responsible authority (the Council) seeks the views of the following Consultation Authorities on whether a PPS is likely to have significant environmental effects and therefore whether a SEA is required:

- ◆ Historic Environment Scotland (HES)
- ◆ Scottish Environmental Protection Agency (SEPA), and
- ◆ NatureScot

As well as consulting the above bodies, responsible authorities are required to take into account the criteria set out in Schedule 2 of the 2005 Act when determining whether or not the plan is likely to have significant effects. The details of this process are contained within the Screening Report.

If the responsible authority and the consultation authorities agree that the plan or programme is unlikely to have significant environmental effects, the responsible authority is required to make a determination to that effect under section 8(1) of the 2005 Act.

### Record of SEA Determination:

In accordance with section 9(1) of the 2005 Act, West Lothian Council submitted to the Consultation Authorities a screening report summarising its views as to whether West Lothian Local Development Plan Supplementary Guidance (SG) – Developer Contributions Towards Cemetery Provision will have significant environmental effects.

In formally determining under Section 8(1) of the Act whether a SEA is required, the council has taken into account the views of the three Consultation Authorities; Scottish Environment Protection Agency, Scottish Natural Heritage and Historic Environment Scotland which were issued through the SEA Gateway on 17 February 2021.

West Lothian Council and the Consultation Authorities are in agreement that the West Lothian Local Development Plan Supplementary Guidance (SG) – Developer Contributions Towards Cemetery Provision is not likely to have significant environmental effects and the council has therefore determined that an SEA will not be required for the plan under Regulation 13(1) of the 2005 Act.

West Lothian Council has undertaken screening of Supplementary Guidance (SG) - Developer Contributions Towards Cemetery Provision with regard to the requirements of section 9 of the Environment Assessment (Scotland) Act 2005.

The Screening Report has been submitted to the Scottish Government SEA Gateway, setting out the views of West Lothian Council on the likelihood of the significant environmental effects of Supplementary Guidance (SG) – Developer Contributions Towards Cemetery Provision with regard to the requirements of section 9 of the Environment Assessment (Scotland) Act 2005 and the potential for requiring a SEA.

<b>Title of PPS:</b>	Supplementary Guidance (SG) – Developer Contributions Towards Cemetery Provision

<p><b>Purpose of PPS:</b></p>	<p>The purpose of this Supplementary Guidance (SG) is to support Local Development Plan Policy INF1 Infrastructure Provision and Developer Obligations.</p> <p>In particular, this SG further defines the terms used in policy INF1 and sets out a developer contribution rate and the methodology for calculating this rate. The rate is to be applied across the whole of West Lothian.</p>
<p><b>What promoted the PPS: (e.g. a legislative, regulatory or administrative provision)</b></p>	<p>Supplementary Planning Guidance (SPG) relating to developer contributions towards cemetery provision was produced to support Policy INF1 of the West Lothian Local Plan (2009).</p> <p>West Lothian Council adopted the West Lothian Local Development Plan on 4 September 2018 after Scottish Ministers confirmed the council could do so. It now forms part of the Development Plan for West Lothian along with the Strategic Development Plan (SDP) for Edinburgh and South-east Scotland.</p> <p>The council has a programme to prepare a suite of new guidance to support the recently adopted West Lothian Local Development Plan.</p> <p>Specifically, Supplementary Guidance – Developer Contributions Towards Cemetery Provision has been written with the intention of becoming statutory supplementary guidance (SG). Supplementary Guidance becomes part of the development plan, giving it the same weight in decision making as the LDP. It has already been subject to consultation but will require to be approved by Scottish Ministers prior to its adoption.</p>
<p><b>PPS Subject: (e.g. transport)</b></p>	<p>The policies are integral to the strategic spatial land use strategy which applies across West Lothian. In terms of this Supplementary Guidance they are particularly associated with developer contributions and delivery of the spatial strategy set out in the LDP.</p>
<p><b>Period covered by the PPS:</b></p>	<p>Anticipated date of adoption following Approval by Scottish Government spring 2021 onwards.</p>
<p><b>Frequency of updates:</b></p>	<p>Under the terms of the Planning etc (Scotland) Act 2006 Supplementary Guidance will ordinarily be reviewed and updated every 5 years, in tandem with the replacement of the</p>

	<p>Local Development Plan. The Planning (Scotland) Act 2019 has removed requirements to prepare supplementary and planning guidance in addition to introducing a requirement to review and update development plans every ten years.</p>
<b>Area Covered by the PPS:</b>	<p>This Supplementary Guidance covers the West Lothian Local Development Plan area. It applies specifically to proposals for developer contributions towards cemetery provision.</p>
<b>Summary of nature/content of PPS:</b>	<p>A Local Development Plan (LDP) is prepared by the local planning authority, in this case West Lothian Council. It sets out a local interpretation of the requirements of national and strategic policy. In particular it must conform to the approved Strategic Development Plan (SDP) which has been prepared by the strategic planning authority (SESplan) and its purpose is to implement requirements on a more detailed site-specific basis than exists within the SDP.</p> <p>The LDP comprises a written statement detailing a spatial strategy, including policies and proposals together with a Proposals Map.</p> <p>LDP's are intended to provide the vision and strategy for how communities will grow and develop in the future and also to provide certainty for communities and prospective investors about where development should take place and where it should not. LDP's also identify the supporting infrastructure required for growth and set out detailed policies and proposals which are the basis for decision making on future planning applications.</p> <p>Policy INF1 (Infrastructure Provision and Developer Obligations) sets out those matters which developers are required to consider and take into account in proposals for development in West Lothian, and requirements for infrastructure to be in place or provided for to support development and the spatial strategy set out in the West Lothian Local Development Plan. The Supplementary Guidance defines terms used in this policy and sets out a developer contribution (obligation) rate and explains how this will be implemented. It provides assistance in the Development Management process.</p>

## Summary of Environmental Effects

The Council has considered the likely significance of effects on the environment of the Supplementary Guidance (SG) – Developer Contributions Towards Cemetery Provision and these are set out below.

### Table 2: Summary of Environmental Effects

Supplementary Guidance (SG) – Developer Contributions Towards Cemetery Provision supports policy INF1 (Infrastructure Provision and Developer Obligations) of the adopted West Lothian Local Development by providing further guidance and detail on the circumstances in which developers will be required to contribute towards cemetery provision in West Lothian.

The West Lothian Local Development Plan has itself already undergone an extensive SEA examining its policies, proposals and land use allocations. They demonstrate West Lothian Council's commitment to sustainability and sustainable development and the addition of Supplementary Guidance (SG) – Developer Contributions Towards Cemetery Provision is considered to strengthen and re-inforce this position.

The Supplementary Guidance forms part of a framework for collection of developer contributions (obligations) required to support delivery of the development strategy set out in the West Lothian Local Development Plan and assist in the determination of planning applications.

The council considers it unlikely that the supporting Supplementary Guidance (SG) – Developer Contributions Towards Cemetery Provision will, in itself, have significant environmental effects as it will provide only information for decision makers, the public and other stakeholders and serve as a management tool in relation to development proposals within West Lothian.

Overall, it is considered that the Supplementary Guidance (SG) – Developer Contributions Towards Cemetery Provision is a qualifying plan or programme that will not have significant environmental effects and that, as part of a wider policy framework, significant environmental effects arising from housing and cemetery development permitted under the terms of the adopted Local Development Plan and associated Supplementary Guidance will be avoided.

It is for this reason that West Lothian Council believes that Supplementary Guidance (SG) – Developer Contributions Towards Cemetery Provision does not require a Strategic Environmental Assessment. However, should a particular instance arise where adherence to the Supplementary Guidance was considered to be potentially detrimental to the environment, the Development Management process would be expected to have regard to such matters and to apply appropriate and proportionate mitigation measures through planning conditions on any planning permissions released by the council.

## Screening Report

Thank you for your consultation which we received on 20 January 2021 about the above screening report. We have reviewed this report in our role as a Consultation Authority under the above Act, in accordance with the requirements of Section 9(3). In doing so we have used the criteria set out in Schedule 2 for determining the likely significance of the effects on the environment.

### Historic Environment Scotland's view

In light of the information and reasoning set out within the screening report, we **agree** with your view that there are **unlikely to be significant environmental effects for the historic environment**.

### Historic Environment Scotland's comments

We understand that the Supplementary Guidance (the SG) provides guidance on the operation of policy INF1 Infrastructure Requirements and Developer Obligations of the adopted the West Lothian Local Development Plan, which has been subject to full SEA. The Supplementary Guidance provides a clear set of guidance and standards to explain what the council will expect from new developments in terms of developer contributions towards cemetery provision.

You consider that the SG itself will not have any significant environmental effects. We are content to agree that significant effects on the historic environment are unlikely.

### Next steps

The Environmental Assessment (Scotland) Act 2005 requires you as the Responsible Authority to determine whether an environmental assessment is required. You must then
