

The purpose of our consultation is to enable the council to establish and maintain a Register of Common Good.

Common Good is property owned by a local authority which has been passed down, through local government reorganisation, from former burghs. Those burghs would have received it as a gift or purchased it. Although there is no statutory definition of Common Good property, it is described as deriving from three sources. These are the original grant, a decision of the Town Council itself or that the land had been used and enjoyed by the public since time immemorial. It can include land and buildings, and moveable items such as furniture and art. It may include cash where property has been sold and income received. West Lothian has four former burghs, namely Armadale Burgh, Bathgate Burgh, Linlithgow Royal Burgh and Whitburn Burgh.

When preparing a Common Good Register, local authorities have an obligation to publish a list of the property that it is proposing to include in the Register and to consult with community councils and community bodies on that list for a period of not less than twelve weeks. The ability to provide views and comments (make representations) before the Common Good Register is formally published ensures that community councils and other community bodies have an opportunity to make a case for property to be included in or excluded from the Register.

Details of the property that West Lothian Council is proposing to include in its Common Good Register are provided <u>HERE</u>

Once a Register of Common Good has been established, the council has an obligation to manage the property contained in that register in accordance with statutory provisions.

In answer to your question, no skills or experience are required in order to participate in this consultation. We are merely asking our communities to identify any property that they think should (or shouldn't) be afforded the status of Common Good given the criteria set out above.
