# How to get involved with LDP 2

West Lothian Council has started work on preparing the next Local Development Plan (LDP 2), which will guide land use and development across the area for the next 10 years. The first step in this process is to set out the **evidence base** for the plan in an Evidence Report.

Draft topic schedules and background papers which form the evidence base have now been published on the council's <u>LDP 2 web page</u>. We are currently inviting feedback on this evidence to identify any agreements or disputes from stakeholders in preparation of the Evidence Report.

## Development plan engagement feedback

The council publishes an updated **Development Plan Scheme** (DPS) at least once a year. The DPS explains what a Development Plan is, outlines how the council intends to prepare and consult on LDP 2, and includes a **Participation Statement** – a guide on how the public can get involved.

The most recent scheme is <u>DPS No. 16</u> which was published in March 2024. We are now working on DPS No. 17 and seeking feedback on the current DPS, as well as the engagement carried out so far.

## **LDP1 Delivery Programme adopted**

While our focus is on the preparation of LDP 2, we remain committed to supporting the delivery of the current local development plan, LDP 1.

On 19<sup>th</sup> November 2024, West Lothian Council adopted the **LDP 1 Delivery Programme 2024**. In line with National Planning Framework 4 (NPF4), this replaces the previously approved LDP 1 Action Programme 2021.

The Delivery Programme sets out the infrastructure, actions and timescales which are necessary to implement LDP 1.

Following consultation with children, young people and adults in West Lothian, the **Play Sufficiency Assessment** (PSA) has been published on the council's LDP 2 web page. This document evaluates play opportunities, helping to understand what is working well and identify gaps in provision that can be addressed in the future.
