We at St David's Brass whole heartedly support the Bathgate Band in its request for an Asset Transfer of the former Bathgate West Nursery.

Having recently completed our own refurbishment of Vogrie Hall in Gorebridge we are beginning to see the advantages of having our own premises. With a purpose-built venue, the band now has an improved rehearsal space that will afford better quality playing time, and the flexible accommodation will cater for our Training Band and any other music groups wishing to utilise the building. A recording studio will also be available for community use.

Equally importantly we will be able to offer the facility to other community groups for their leisure activities - we have 14 such groups which have already expressed an interest in using our Expressive Arts Centre. This proves the need for such a venue and justifies our decision to forge ahead with our plans.

We firmly believe that the Bathgate community will benefit hugely from the Bathgate Band's venture. Dear Sir/Madam

I feel compelled to write to you in the hope that you take notice of a recent request from The Bathgate Band in securing the Bathgate West Nursery building as a much needed Music Hub for the community. I write as a busy professional musician whose first spark of interest, at the tender age of 8 year old, was welcomed and nurtured by the good people at the band back in the 1980's.

As a young girl (youngest of three) from a very working class family (my father was a carpenter/joiner and my mother was a carer for the elderly) living in social housing in Bruce Road, aspiration was high yet my parents were continually beset by all kinds of financial restrictions. My father happened to be working alongside a colleague whose hobby was brass banding and the rest, they say, is history. Within two years, my whole family was involved in the band - all three children learning brass instruments while both parents became committee members and helped with fundraising and day to day running. We were given instruments on loan and paid a tiny fee to be members of the junior band - an absolute lifeline to a family who struggled financially and an introduction to likeminded people who became lifelong friends. The old adage that it takes a community to bring up a child is no truer in my case. As a teenager working through GCSE and Higher exams, my financially strapped parents, again, turned to the band where I had the great privilege of having help with Maths, Chemistry , English and French all from members or their extended family within the band.

To say my formative years in the band were my key to social mobility would be a gross understatement. It has enabled world travel and many exciting opportunities including performing in some of the world's most famous concert halls, theatres and recorded many sound tracks for TV and blockbuster films. In the last year alone, I have been a guest principal trumpet in orchestras such as the London Symphony Orchestra and the Royal Philharmonic Orchestra and, currently, engaged by the Jamie Lloyd Company to perform Andrew Lloyd Webber's 'Evita' starring Rachel Zegler.

As a professional musician, I have always had the great privilege of being able to teach in various educational settings, although lately this has mostly been in the independent sector due to huge cut backs in music education. It disturbs me that my eight year old self would not be given the chance to learn an instrument these days as I know my parents would be too financially stretched. This is why it is of the greatest importance that the Bathgate Band can continue to serve the community - as it always has done - and to

provide a great service for the young and the old. We live in a very diverse and multicultural society. Music has the ability to unite communities for a common cause and we need only look at Darren Barenboim's West Eastern Divan Orchestra - Israeli and Arab musicians uniting to create world class music - as a stellar example. West Lothian's musical heritage

West Lothian has a long history of developing and supporting world-class musical talent – from brass bands, pipe bands, and solo artists to the range of ensembles that have made up the West Lothian Instrumental Music Service over the years. Generations of young people have found a love of music, friends for life and skills which have taken them far and wide, all because they first picked up an instrument in West Lothian. As a former teacher, I have seen firsthand the skills and confidence that young people develop through music. This goes far beyond one instrument or one performance – these are skills which set young people on a path for success in any career. As a young person, I played in the West Lothian String Orchestra and Junior Orchestra for many years, experiences which even took me on an exchange trip to Germany as a teenager.

West Lothian Council has rightly placed huge importance on music education and ensembles over the years. It would therefore be entirely fitting for a community asset transfer to result in the establishment of Bathgate Music Hub, in the heart of the community, to continue West Lothian's musical traditions.

Benefits for the community

The potential positive impacts of Bathgate Music Hub for a wide range of groups in the community are hugely significant. I have heard from the Bathgate Music Hub team powerful testimony of people living alone who find community and a sense of belonging in Bathgate Band; of elderly people in care homes benefiting from music sessions; of young people growing in confidence and overcoming mental health struggles; of young adults who have gained skills and found job opportunities not previously open to them. All of these are made possible because of the various ensembles, groups and initiatives who would use the Bathgate Music Hub. The positive impact of these various initiatives on the wider community, and indeed economy, would be transformative for Bathgate and the surrounding area.

Local facility

The former Bathgate West Nursery is ideally located in the heart of the community in Bathgate, making the Bathgate Music Hub accessible to people. It seems only right that Bathgate institutions such as Bathgate Band and Boghall & Bathgate Pipe Band should have a home in their community. But this proposal also has the potential to reach out further into the community, with options for lessons and other community projects which would make the Bathgate Music Hub a focal point of the town.

Bathgate Music Hub Community Asset Transfer

I am writing in support of Bathgate Band regarding their current bid for an asset transfer of the former Bathgate West Nursery estate in order to establish a permanent base in the town for the band and to develop a music hub for the wider area.

With over 180 years of history, Bathgate Band are one of Scotland's oldest brass bands, part of a unique and rich musical tradition woven into the town's mining and industrial heritage. The band have worked for several years to re-establish a base in Bathgate and this asset transfer provides a fantastic opportunity to realise their ambition whilst retaining a much-loved community building as an educational hub for the benefit of the town and the wider area.

West Lothian boasts a music scene with international status and influence. Growing up in Bathgate I was lucky enough to benefit from this before studying piano at the Birmingham and Utrecht conservatoires. Numerous studies have shown the wide range of benefits music education can provide, impacting people's cognitive, social, emotional and academic development. At a time when our society is experiencing a loneliness crisis, music, as a universal language, has the potential to foster inclusivity and promote social harmony and community.

The former Bathgate West Nursery holds a special place for many in the community whose grandparents may have attended when it was a school or who themselves or their children have attended as a nursery. This central location would bring welcome footfall into the heart of the town while providing a much-needed community space to support local civic events such as the annual procession.

Located between two of Scotland's main cultural centres I believe a music hub in Bathgate would provide an invaluable focal point to continue developing West Lothian's own unique cultural scene while building links with the surrounding areas and organisations such as the Royal Conservatoire of Scotland in Glasgow. Live music plays a vital role in Scotland's economy with 2.3 million music tourists visiting the country in 2024, generating £857m in music tourism spend and supporting around 7,160 FTE jobs. With its fantastic transport links and central location Bathgate is well placed to become a key part of Scotland's wider music eco-system.
