SCOTTISH PARLIAMENTARY ELECTION ON THURSDAY 7 MAY 2026

2. As more than one person stands nominated, a poll will be taken on Thursday 7 May 2026.
3. The poll will open at 7.00 am and will close at 10.00 pm. Voters already in a queue at their polling station at the close of poll will be entitled to apply for ballot papers.
4. The names of the candidates will be printed on the constituency ballot paper in the order shown above.
5. The poll will include the election of members of the Scottish Parliament for the Central Scotland and Lothians West Region. A separate ballot paper of a different colour will be issued for the election of those members.

6. Applications to be included in the register of electors to be used at this election must reach the Electoral Registration Officer by midnight on Monday 20 April 2026.
7. Applications to vote by post at this election must reach the Electoral Registration Officer by 5.00 pm on Tuesday 21 April 2026.
8. Applications to vote by proxy at this election must reach the Electoral Registration Officer by 5.00 pm on Tuesday 28 April 2026. Emergency proxy applications may be made after that to the same address by 5.00 pm on Thursday 7 May 2026.
